



## Request for Membership

**The Council of Professional Investigators – Atlantic Canada** is a non-profit corporation established to represent the interests of private investigators licensed in New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland. As the only organization representing the professionalism of our industry, our goals are forever changing. One of its main activities is the organization of periodic professional development seminars. It is also active in pursuing, with the Registrars, any breaches against our governing Acts, including incidents of unlicensed investigators and other matters of concern to the private investigation industry.

### **Special Notice:**

Membership is valid for one year commencing May 1<sup>st</sup> and expiring on April 30<sup>th</sup> the following year. Applicants must agree to comply with the CPI-AC Codes of Ethics, Conduct and Privacy. These Codes will be made available to all members through our website. By signing this application, the applicant agrees to adhere to these Codes that maintain the professionalism of not just our Association, but industry at large.

### **Corporate Member:**

Any agency licensed to engage in the business of providing private investigations in one or more of the Atlantic provinces. This includes one regular membership, plus the right to advertise membership in the Council. The corporate fee is \$150, which entitles the company to one individual membership with voting rights. **We encourage that agency members ensure that their licensed professional investigators become members of the CPI-AC.** Copies of Corporate and Individual licences must be included.

### **Regular Member:**

In order to be a regular member, the applicant **must** be a licensed Private Investigator in one or more of the Atlantic Provinces or be employed by a Corporate Member of the Council. Regular memberships fees are \$35 per member and includes voting rights. Copies of your Individual licence and resume must be included.

### **Associate Member:**

Associate memberships are restricted to those employed in the investigations field, including insurance investigators dedicated to SIU, Forensic Accountants, Forensic Engineers, non-law enforcement or government investigators, and out of province or country private investigators. Associate memberships fees are \$35 per member and **does not** include voting rights. Copies of your Individual licence, or letter of reference, and resume must be included.

### **Student Member:**

Student memberships **must be** enrolled in a relevant accredited field of study and will require references letters from either the Program Co-ordinator or Dean, along with a resume. Student memberships fees are \$25 per member and **does not** include voting rights.
